The three pillars of Ethical Fashion are: - **Social Good**, **Planet Friendly & Animal-Free** 

**Social Good**: This means fair wages, fair trade certifications, and access to good working conditions. One brand that is fully committed to doing Social Good for the community in comparison to ethics is Vildnis. They work exclusively with small factories based in Portugal and India. Keeping manufacturing in a few places allows them to visit the factories more frequently and check that the workers are treated well.

When people think of sustainable fashion, we think of the environment. By planet, we mean all things earthly, like water, the ground, and the climate. Another one we may have heard of is Slow Fashion. Which is opposite of Fast Fashion, and Fast Fashion is buying and throwing away clothes in landfills. ## 1.2 The Vegan leather industry

Vegan leather is made from many plant-based fibers, including pineapple leaves (Pinatex), cactus (Desserto leather), Apple Peels, Mushrooms, Coconut husks, Mango, Seaweed, and Banana peels. Lab-grown leathers like MYLO, an "unleather" material made from mycelium, are also bursting onto the fashion scene. (Rollin 2005). As these fibers are often used as a byproducts of food industry, they're not creating a demand for a resource or extracting more from the planet, but rather using up or otherwise been thrown away. The awareness of fake fur as a vegan material and ethical alternative material has increased compared to that in the past however, fake leather is still recognized as an industrial material rather than a vegan material. Pinatex is a material resulting from 'discarded' pineapple. Pinatex is a new word form from 'Pina' the Spanish word for pineapple and 'Tex' which refers to the texture of pina fibers. Before Pinatex, pineapple leaves were considered rubbish and discarded. The Philippines, Brazil, and Hawaii were throwing away millions of tons each year. Thanks to Pinatex's innovation, these materials have gained a new life. As a designer, one can use it as a cruelty-free (vegan) leather alternative in your fashion creations, looking good while saving the environment, at the same time. The advantage of using the leaves of the pineapple is rescued from waste and turned into resources that fashion brands are into.

## 1.4 Vegan Fur made from Seaweed.

Another fantastic material that's making recent waves is Koba. Koba is an innovative type of animal-free fur made from kelp seaweed. The innovation follows in the pace of ECOPEL, the very first bio-based fur company that has made vegan fur for manufacturing of apparel. After fashion houses began to ban animal fur, made from kelp has started to become increasingly popular. Right now, more than 300 leading fashion houses are using Koba fur. This has a great place regarding the future of sustainable fashion made from corn. Koba is far more sustainable than faux fur made from nylon, polyester, and other plastic materials.

#### 1.5 Animal-Free Wool from Coconut Husks

As a natural fiber, coir is used in simple products such as floor mats, ropes, doormats, brushes, and mattresses. According to recent data an animal-free alternative to wool, which is Coir could save over 450,000 tons of carbon emissions on an annual basis. Recent innovations have improved Coir to the point of being used as a wool replacement in fashion and apparel products. Moreover, if blended with other materials, the coconut fabric adds drying fast. That makes this material excellent for fitness gear, as it keeps the wearer cool. Many US brands such as Polar Tec, Orvis, and Marmot have launched their collections of Coir-based brands.

Apple leather is a vegan leather-like material that is completely free from animals, making it the perfect material for anyone. The material was developed by Frumat and is made by Mabel, an Italian manufacturer. Relatively new, the material, which is officially named Apple Skin, was first made into bags in 2019. Apple leather is a bio-based material, meaning that it is partly biological: natural, and organic. In the Tyrol region of northern Italy, an enormous number of apples are grown. When making juice or jam, the seeds, stalks, and skins of apples can't be used. These peels are composed of apple skin leather. Today, Frumat collects these otherwise wasted fruit scraps and turns them into fashionable material. The leftovers, like the apples turned to juice, are crushed, and then naturally dried into a fine powder. This powder is blended with a kind of resin that is, essentially, dried and laid flat into a final material -- apple leather.

#### 1.7 Mushroom Leather

Mushroom leather is a vegan-friendly material used as a sustainable and environmentally friendly alternative to animal leather. Mushroom leather is made from mycelium, the vegetative part of a fungus. Mycelium is the network of filaments that form the underground thread-like structure of fungi. It is the branching structure of mushrooms, made from billions of tiny cells.

## 1.8 Mango Leather

Hugo and his family have been in the leather business since 1952, but this is the first time they have processed vegan leather. The co-founder's dream is to decrease food waste while making the leather industry more environmentally friendly. The vegan leather is made from thousands of mangoes that would otherwise be thrown away. Now, this waste is used to make jackets, wallets, handbags, and shoes.

#### 1.9 Cruelty-free Silk from Banana Stem

Bananas as we know are one of the most known and loved fruits all over the world. But, apart from being loved for its edible part, it seems that this fruit will soon find love for its stems (abaca) as well. It is said that roughly one billion tons of banana stems are discarded every year. Some researchers have found a way to take these wasted stems and put them to good use – Abaca for fashion. The conversion process requires around 35 kilograms of stems. In the end, about one kilogram of super-soft fiber results, ready to be turned into textiles. Abaca-based fabrics are suitable for both humans and the environment. From all sustainable materials, Abaca requires less land, water, and fertilizers to grow. Moreover, extracting textiles from banana stems requires minimal energy usage and little water consumption.
