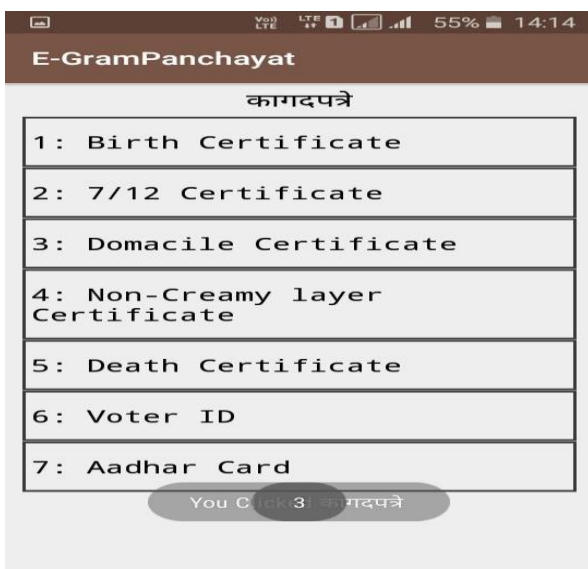
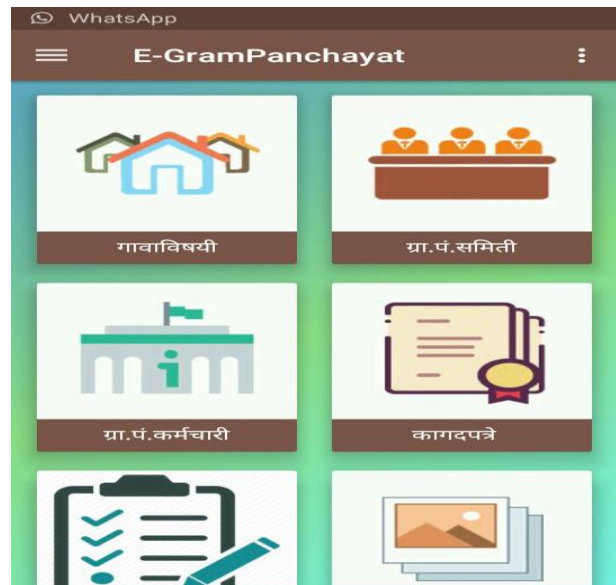
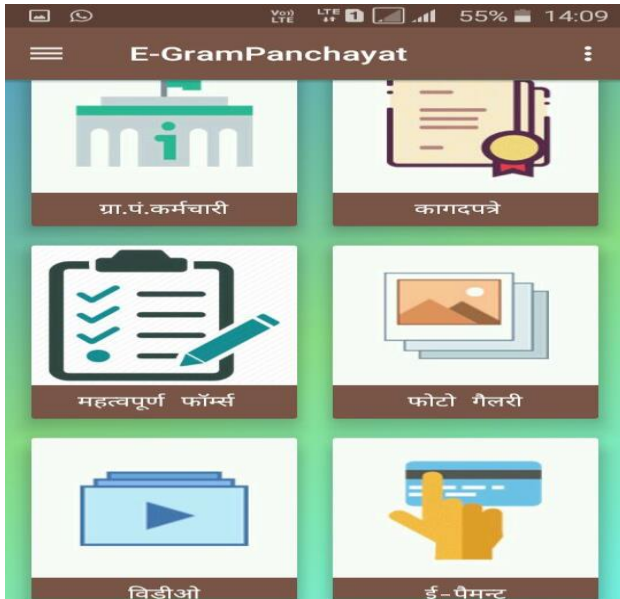
#### 4. DESIGN AND PROPOSED SYSTEM
