Daily average COVID-19 waste generated in Mumbai (in kg)

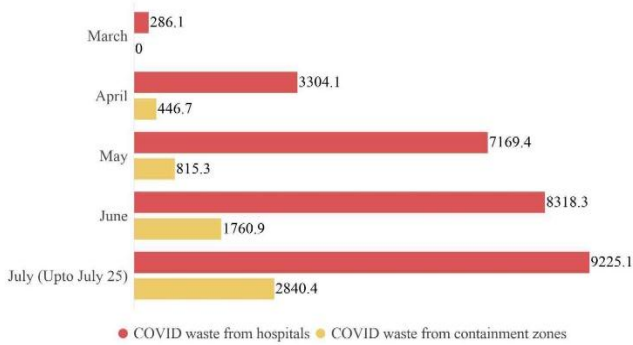


Fig 4.1 Impact Of Covid-19 Pandemic On Waste Management

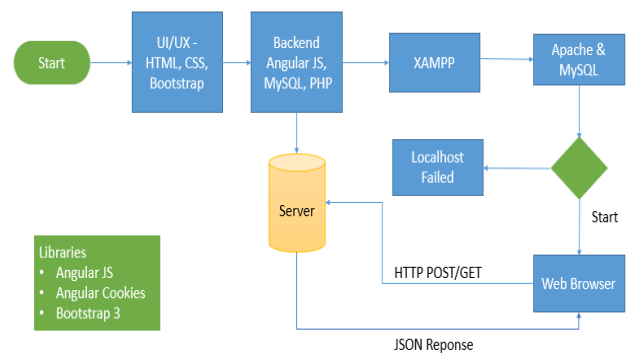


Figure 6.1 Work Flow Diagram

Admin can see area of waste Collecting Vehicle . This will allows to supervising at the Truck management ,in order that admin get guarantee that work is finished or not.

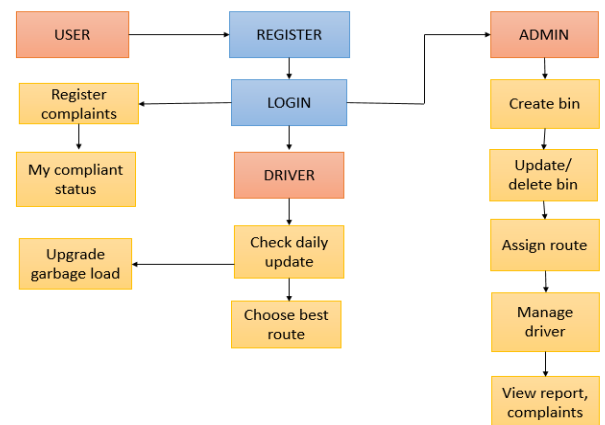


Figure 6.2 Architecture Diagram

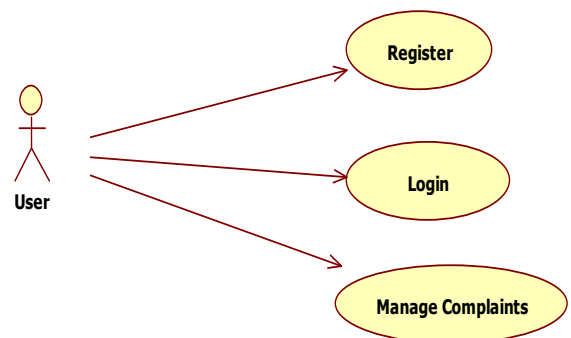


Figure 6.3 User use case diagram

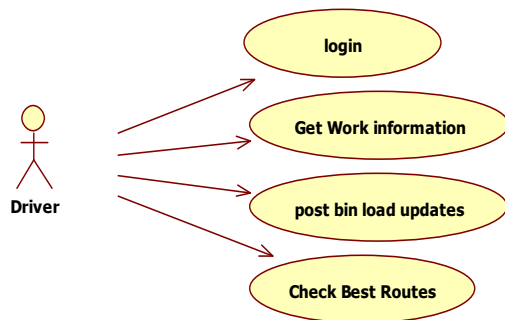


Figure 6.4 Driver use case diagram

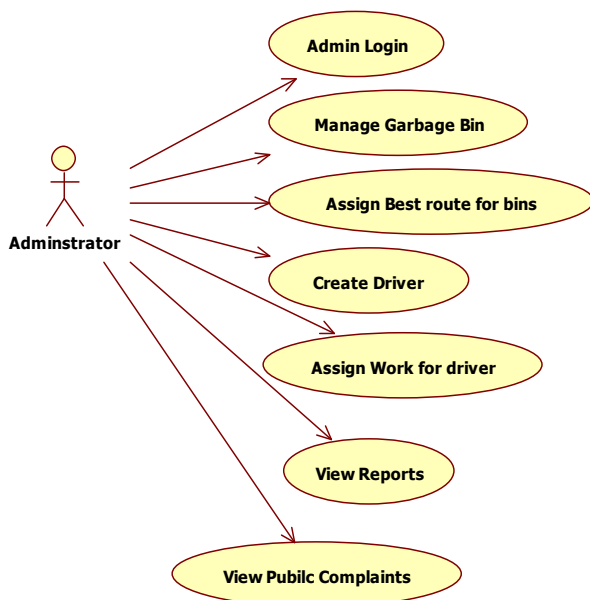


Figure 6.5 Admin use case diagram

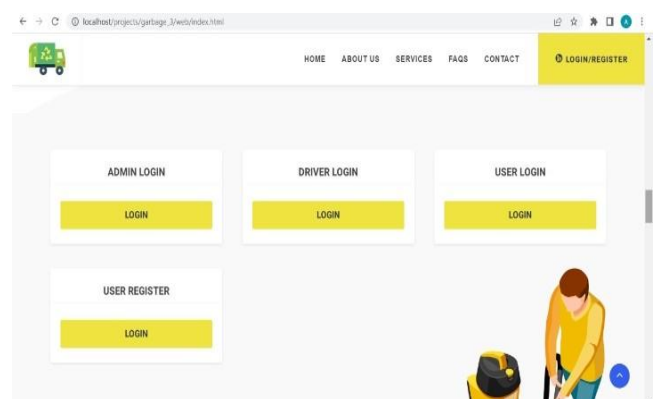
## 10. RESULT AND DISCUSSION

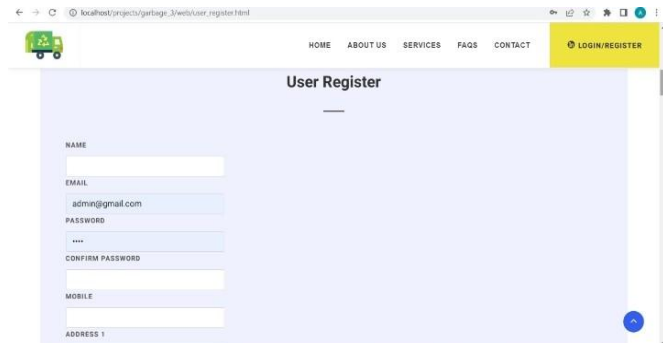
**Fig 10.1 Home Page :** This is home page of Covid Hazardous Garbage Management System where containing navigation menus.



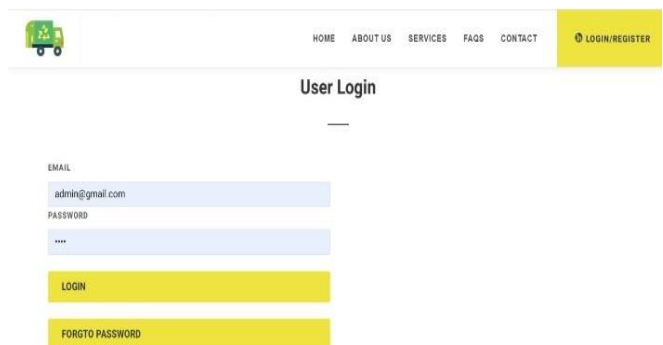
**Fig 10.2 Login Page :** There are total three login section are available such as admin login, Driver login, User login.



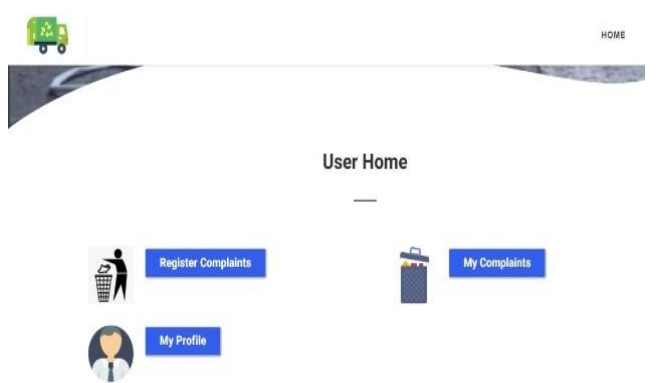
**Fig 10.3 User Register Page :** Here user should register before user login using his/her Name, Email, Password and Mobile No. After successful registration user will be able to login into system.



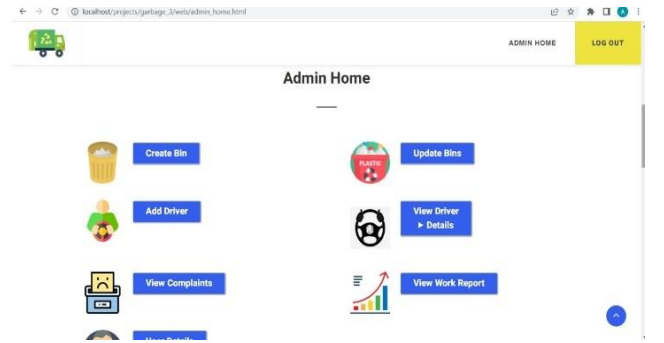
**Fig 10.4 User Login Page :** After registration user will be able to login into system by providing Email and Password.



**Fig 10.5 User Home Page :** This is User home page. There are three sections available, user can register their complaints, and view their complaints. Also user can see their personal information in My Profile.



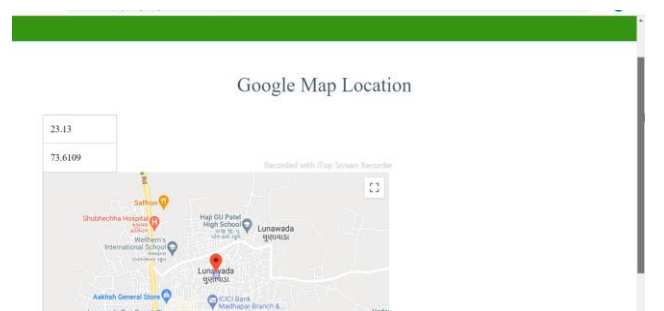
**Fig 10.6 Admin Home Page :** In admin home admin assign driver for collecting bins and see work is completed or not, view work report he can create bin and update bins also he can view complaints from user.



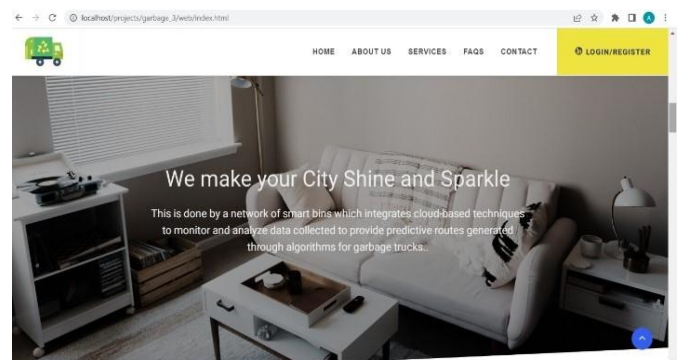
**Fig 10.7 Services :** Here we shown our work that we done in different areas



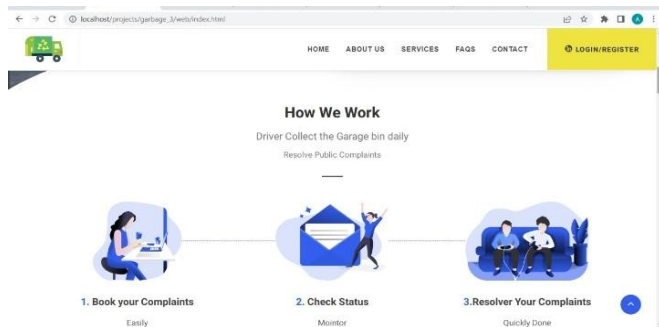
**Fig 10.8 Assign Route :** Admin finds best route for the driver for garbage collection in particular area.

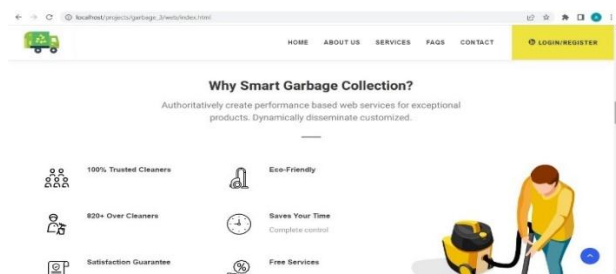
**Fig 10.10 Work Description :** Here we shows work detail provide by us



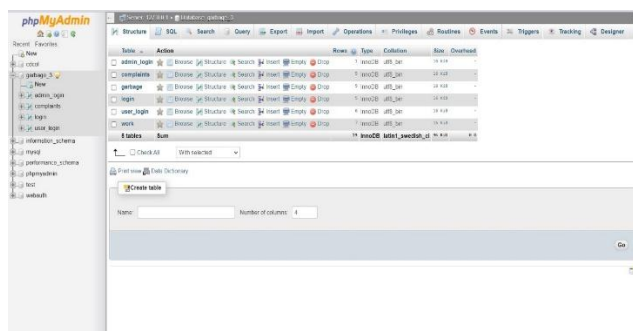
**Fig 10.11**
